Sub: National Web Portal (www.mhrdnats.gov.in) for facilitating establishments, institutions and technical students for seamless sharing of information.

Dear Sirs / Madam,

The four Boards of Apprenticeship Training / Board of Practical Training (BOATs/BOPT) are located at Mumbai, Kanpur, Chennai & Kolkata. They are autonomous organizations of the Ministry of Human Resource Development (MHRD) and facilitate skill training to Engineering Graduates & Diploma holders and 10+2 Vocational Certificate holders through the National Apprenticeship Training Scheme (NATS). The objective of 'Apprenticeship Training' is to fill/match gaps in the skills and experience of students and to establish liaison between industries / establishments and technical institutions in developing skilled manpower for the nation.

Under the NATS implemented by MHRD through the four BOATs/BOPT, one year practical training in industry/establishment is provided to students to upgrade their skills in a particular trade. Apprentices are paid a monthly stipend of Rs.4984/- p.m. for Graduates, Rs.3542/- p.m. for Diploma holders and Rs.2758/- p.m. for 10+2 Vocational Apprentices. 50% of the minimum stipend rate is reimbursable to the employers from the Government of India through the four BOATs/BOPT.

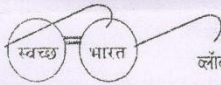
Earlier, four regional BOATs/BOPT had four different portals. A person residing in a particular region needed to apply through the Board functioning in that region for registering himself as an 'Apprentice'. Thus, students had to face restrictions in registering themselves with Boards of Apprenticeship Training outside their region.

National Portal for E-Transaction

The Hon'ble Minister for Human Resource Development launched the National Web Portal of the NATS on 10th September, 2015. This portal provides connectivity with stake holders including students and establishments for transparent administration. The paperless online business transaction will improve effective reporting capabilities through online data sharing and ensure standardization of processes across regions and ensure uniformity in the implementation of the NATS. The portal is also available on multilingual platform. We request all the stake holders, the students, the establishments and the technical institutions, in particular to make a note of the following and give a wider publicity of the information leading to increased awareness about the portal as well as the Scheme. All the four Regional Boards has implemented the National Portal (www.mhrdnats.gov.in) w.e.f 01.04.2016. Due to this transition, all the stake holders are requested to note the following points for mandatory compliance at their end.

1. It is mandatory for all the technically qualified students [Graduate, Diploma holder Engineers as well as 10(+2) Vocational Certificate holders] to enroll themselves on the portal for availing Apprenticeship Training facility. The students not enrolled on the National Web portal within three years of their passing will lose their chances to undergo one year Apprenticeship Training even thereafter. Therefore, it is mandatory that students immediately after publish of result must enroll themselves. The role of Technical Institutions to propagate and disseminate this information to their final year students is very important.

In respect of student passing out in the discipline of Mining Engineering / Mining Survey etc. where the training is very important in order to obtain mining certificate from Director General of Safe and Mines. Please note the following for immediate action at your end.

- All students of your institute who have passed out in the year 2013, 2014 & 2015 and are expected to pass in the year 2016 must be asked to enroll immediately on the National Portal (www.mhrdnats.gov.in). For enrolment the students are allowed only up to 3 years from year of the passing.
 - Since first of July all the establishments in general and subsidiary of Coal India Limited in particular would be provisioned to select and engage apprentices from the National Portal data base. No more sponsoring of candidates from BOPT would be done. It is in line with the resolution adopted in the meeting of all stake holders in this regard vis-a-vis institutes and establishments and respective mining engineering / survey held at Ranchi on 05.11.2015.
- All the technical institutions producing Graduate, Diploma Engineers as well as 10(+2) Vocational Certificate holders are also required to take pro-active actions for ensuring utility of the National Webportal at www.mhrdnats.gov.in using their user id and password. In case they do not have their user id and password, they may contact BOPT (ER) office for obtaining their individual user id and password through e-mail communication addressed to ad1@boptr.gov.in; ad2@boptr.gov.in and ad3@boptr.gov.in.

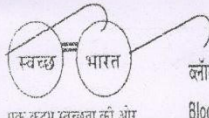
Therefore, it is the responsibility of the Technical Institutions to maintain and update their institutional profile in the National Webportal (www.mhrdnats.gov.in) using their user ID and Password at regular interval of time. Please note that the institutions not following the same will restrict their students the time of enrolment. Students of such institutions/colleges will not be able to enroll.

- Technical institutions are also required to take pro-active actions for increasing awareness level about the National Apprenticeship Training Scheme being facilitated through National Webportal among the students in coordination with BOPT (ER). They must also provide a link of the National Webportal (www.mhrdnats.gov.in) on their website home page so as to provide an open platform for their students to gather information about the Scheme. To receive the linkage institutions are requested to send a communication in this regard to cp@boptr.gov.in.

Institutions who already enrolled in the past with the BOPT (ER) portal at www.boptr.com, their data has been migrated to the new portal www.mhrdnats.gov.in, they are requested to obtain their user id and password, if not available with them from BOPT (ER) by contacting the Officers whose details are provided in this communication. - Institutions enrolled with the national portal and continuously updated their profile would also be entitled to receive special facility in terms of features that would be available at their door step.

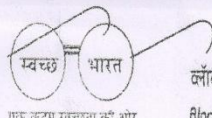
